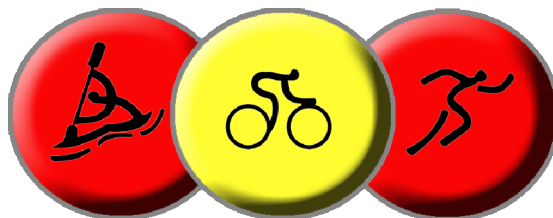


Tour Waiver

In consideration of acceptance for participation in:

the Participant agrees to the following conditions:

1. Sierra Sports & Tours, its employees, agents, affiliates, contractors, volunteers and or suppliers of service in connection with any tour or service do not assume any liability whatsoever for any injury, damage, death, loss, accident or delay to person or property due to an act of negligence or of default of any hotel, carrier, restaurant, company or person rendering any services included in the tour or by Act of God. Further, no responsibilities are accepted for any damage or delay due to sickness, theft, labour disputes, machinery breakdown, government restraints, weather or other services beyond their control.
2. I acknowledge that participating in recreational activities, such as, cycling, hiking and triathlon to a name a few involve the real risk of serious injury or death from causes including but not limited to overexertion, equipment failure, dehydration, accidents with other participants/pedestrians/road users, and weather conditions.
3. By booking a tour and/or service with Sierra Sports & Tours I accept all the risks from my participation that could result in loss of life or permanent injury. In addition, I release all people associated with Sierra Sports & Tours from, and will indemnify them against, all liability for all injury, loss or damage arising out of or connected with my participation. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
4. I understand that I should not sign up to any tour and/or service provided by Sierra Sports & Tours unless I have trained appropriately and a medical practitioner has verified my physical condition. I have detailed in my booking form details of any existing or previous medical or physical conditions from which I suffer or have suffered that might affect my performance or be relevant if medical treatment is needed.
5. I consent to receiving any medical treatment the Sierra Sports & Tours team thinks necessary during any tour and/or service they offer.
6. Safety precautions undertaken by Sierra Sports & Tours (such as guided supervision, safety briefings, safe cycling tips, compulsory inductions to risk assessment documentation and bicycle and helmet safety checks to name a few) are a service to me and other participants but are not a guarantee of safety.
7. I am fully responsible for the security of my personal possessions and any additional hire items I purchase during any tour and/or service provided by Sierra Sports & Tours.
8. I agree to abide by all directions issued by Sierra Sports & Tours representatives or agents.
9. Should any of the guides or tour leaders be unable to perform their duties due to accident, illness or other unforeseen event, Sierra Sports & Tours reserves the right to replace them with other tour guides or tour leaders.
